SAND LAKE Eurasian Watermilfoil Infestation

As everyone undoubtedly knows by now, Sand Lake was discovered in August, 2003 to nave an intestation of Eurasian Watermilfoil.

Considerable effort has been expended by our association to date in 2004 to formulate a go-forward plan to

address this problem.

Eurasian Watermilfoil is an emotional issue due to its ability to spread and mat at the surface to such an extent that it is problematic to swimmers, boaters and general fishing; the sad reality is that it is probably only a matter of time before this non-native aquatic plant invades the other lakes in our area. Accordingly, we face a future challenge in addressing the watermilfoil issue.

Dan Swanson, MN DNR Exotics office was the guest speaker at our July, 2004 general membership meeting. He indicated that Eurasian Watermilfoil was first discovered in Lake Minnetonka in 1987 and has now been found in 165 lakes in Minnesota. Dan explained how it spreads, methods to attack the problem and what

the public can do to minimize further spread.

Chip Welling heads the MN DNR Exotics Species office. He advises that some 140 milfoil-infested lakes in Minnesota are currently undergoing treatment to control the spread of milfoil. Eradication has not occurred

in even one of these lakes. In short, once infestation occurs, control is the only recourse.

One might ask why Eurasian Watermilfoil can't be eradicated. The simplistic answers are: one can't dig out all of the plants; they fragment and the fragments create new plants. Chemicals strong enough to absolutely kill all the growth would likewise kill useful native plants and fish; so a safe compromise chemical treatment can only help in the control process. Finally, each property owner is responsible for the control of aquatic plants within 150 feet of the shoreline of their property. Not all property owners are typically willing to apply or pay for a DNR permit to treat or additionally pay for the cost of treatment at their shoreline if the growth of the plant is such that use of the lake water is just a nuisance instead of a problem.

DNR EURASIAN WATERMILFOIL GRANT FUNDING

We learned in early August, 2004 that the MN DNR received some supplemental funding in support of their 2004 milfoil program. On August 6th, we applied for grant funding to pay for a comprehensive survey of aquatics in Sand Lake. Our application was approved and we were given a grant in the sum of \$1775 on August 19th. Conditions of the grant were the procurement of at least two bids from independent licensed contractors and conduct of the survey before the end of September to ensure a survey before the milfoil went dorment. We requested bids from four potential contractors, received three written bids and contracted with Blue Water Science, St. Paul, to conduct the survey at a cost of \$1775.

A comprehensive aquatic plant survey of Sand Lake was conducted on September 8th by Mr. Steve McComas of Blue Water Science. The written report is not expected before early November. However, Steve telephonically advised the following: Eurasian Watermilfoil has not spread substantially beyond those locations earlier detected by the DNR one year ago. Existing milfoil consists of single stems, with none branching or

reaching the surface. In other words, no matting has yet formed.

Once we receive the comprehensive written report, we provide a copy to the DNR, along with our claim for grant funding to reimburse our expenditure for the survey. The next step over the winter months will be a coordinated effort with the DNR, based on the Blue Water Science report, to formulate a formal aquatic plant management plan for Sand Lake, which will serve as a combined DNR/lake association plan for future treatment/control of Eurasian Watermilfoil at Sand Lake.

FISH ARE REALLY BITING IN ISLAND LAKE, BOY DISCOVERS

(The following is a reprint of an article from the Saturday, August 28, 2004 issue of the Duluth News Tribune) By Sam Cook, News Tribune Outdoors Writer

One moment, 11-year-old Mason DeRosier was hunting frogs. The next, he became the hunted.

Mason and his 9-year-old sister, Katelyn, were wading in about a foot of water on Island Lake, near Moose Lake, when he was attacked by a muskellunge or a northern pike. The resulting lacerations required 11 stitches.

Both kids are from Silver Bay and were at a family cabin on Island Lake when the incident occurred about 5 p. m., Thursday.

Mason's father, Richard DeRosier, was in a paddle boat just offshore and witnessed the event.

"I was facing them, and I see a hell of a swirl," said DeRosier, a Lake County deputy sheriff. "Before I can say Holy moly! Look at that!" all of a sudden the swirl is by their feet."

Mason saw the original swirl just offshore.

"It was like maybe five feet in front of us," Mason said. "Then it splashed right at my foot and bit me. It hurt." And the fish didn't let go immediately.

"I smacked it in the head and tried to pry it off my foot," Mason said. "He let go, but he bit my hand."

Both children were screaming throughout the incident, their father said. Katelyn wasn't bitten.

Mason was taken in his grandfather's motorboat back to the cabin, where he washed his wounds. Then he was off to the hospital emergency room in Moose Lake.

He received eight stitches in his left hand and three in the bottom of his right foot. He has numerous other bite marks across the top of his foot, his dad said.

"I'll bet he has 20 cuts on his foot and 10 cuts on his hand," Richard DeRosier said.

Nobody got a good look at the fish. Island Lake, just across Interstate 35 from Sand Lake in Pine County, has muskies and northern pike, according to the Minnesota Department of Natural Resources. Either species would be capable of inflicting the kind of wounds Mason suffered.

Because Mason's foot hurts too much to walk on, the family decided to postpone a planned trip to Valleyfair in Shakopee, Minn. On Friday, Mason was back at the cabin recuperating.

But he and Katelyn weren't chasing any frogs.

Seasonal vs residential population: As a part of the 2003 LAP study of Sand Lake, our Association had to submit a survey on the number of lakeshore properties that are seasonal versus year-around. We went to the county assessor's office for a computer run—the computer time was no more costly for a run of Sturgeon and Island Lakes than it would have been for just Sand Lake, so we thought it would be interesting to have the figures for all three lakes. This is a reprint from our Fall, 2003 newsletter, but due to continuing interest, here it is again:

The figures do not include non-shoreline properties; example: If 40 dwellings off the lakeshore share a single piece of shoreline as a common beach, the figures reflect only 1 shoreline owner. Still, the mix is interesting.
