V. COMMITTEE REPORTS

a. Lakes:

We asked for and received \$25,000 from Pine County to help us with the total lake treating of Sand and Sturgeon lakes for EWM. We also applied for a waiver to help us with obtaining the permission of lakeshore property owners to treat their lakeshore

Dennis Huddleston reported on Sturgeon Lake. He has found a considerable amount of EWM near the public access and also on the north side of Sturgeon Island.. He will ride with DNR Rich Rezanka as he surveys the lake.

Chip Wells reported for Ron Hansen on Island Lake. The letter, chart and pictures Ron sent to Heidi Lindgren, the state hydrologist, have been received by her and she is aware of the problem.

Jerry Blasevic reported on Sand Lake. The lake has risen 6 inches with spring rains. Jerry monitors the lake level for the DNR. He will be riding with DNR Rich Rezanka as he surveys the lake for invasive species..

Laurie Patrick reported on Passenger Lake and says all is well there.

b. Brush:

Dennis Huddleston mans the brush pile in the airport quarry on the 3rd Saturday of each month from May thru October. 10:00 to 1:00. He would like some help with this job.

c. Membership;

Chip Wells reported that as of mid-week we have 159 members. Island 26, Sand 70, Sturgeon 55 and small lakes 8.

d. Road Pick up:

Chip Wells asked for someone to take over this committee. We have been picking up 8 ½ miles of roads for a number of years. No one offered. We will check again at the July meeting.

e. Newsletter:

Our spring newsletter went out to members in April.

f. Website:

So, where ever the DNR survey finds EWM, it will be treated..onshore and offshore.
- e. Other...In our continuing drive for memberships, the board decided to purchase two banners to display on pontoons, etc. advertising the lake association.

We will also have a float in the Moose Lake 4th of July parade.
