## MINUTES OF JUNE 8, 2013 GENERAL MEETING

## WINDEMERE TOWNSHIP LAKE & LANDOWNERS ASSO.

I.Chair Chip Wells called the meeting to order at 9 AM.

II.Roll was called: Those present were: Janette Muller, Shirley LaFond, Laurie Patrick, Pauline Dee, Ron Hansen, Ron Goettsch, Dennis Huddleston, Tom Landsberger, and Chip Wells.

III. The minutes of the August 11, 1012 general meeting were read and approved.

IV.The treasurer's report showed we have \$29,301.31 in the checkbook. Of that, \$18,945.55 is in the Eurasian Water Milfoil(EWM) fund, \$1,257.23 is in the Water Quality fund, \$245.00 is in the Memorial fund and \$8853.53 is in the General fund. Treasurer Janette Muller announced that the Sturgeon-Rush Association has once again given us \$500.00 for help with EWM

## V. COMMITTEE REPORTS

a.Lakes: Sturgeon Lake...Dennis Huddleston reported that Strurgeon has been permitted to have 18 acres of EWM sprayed by Lake Management, Inc. if needed.

Island Lake...Ron Hansen reported on the study we had done last fall by A.W. Research on the lake level and it's connection with the large algae blooms that occur there during the summer. More work will be done with this problem. Ron also brought up the culvert problem at the outflow of the lake. This growing problem will again be addressed this year as it was in 2001 and in 2012.

Passenger, Rush , Johnson, Lake 11 and Lake 12...Laurie Patrick reported these are lakes with no public access, therefore, the DNR does not get involved with them.

Sand Lake...Pauline Dee reported Sand has been permitted for 15 acres of EWM to be sprayed by Lake Management, Inc. if needed. The weather is too cold, as is the water, for EWM to begin to grow so it cannot be surveyed yet. Perhaps in 2 weeks or so this will happen and the acreage will be determined. This survey is on the off-shore or outer waters..150 feet out from shore. The cost for the spraying this year is \$566.00 an acre. We will receive grant money from the state at \$100.00 an acre to help with the cost. Rich Rezanka, the DNR invasive species specialist for our area will do the survey and inform us of the findings. The lakeshore properties where property owners have indicated a need for spraying their shoreline will hopefully be sprayed at the same time the outer waters will be done. The cost for lakeshore spraying is up to the property owner.

The Fisheries department reported that the biggest issue in 2012 was a population study of Sand Lake. They found that the smaller Northerns are overabundant and a slot rule may be applied in Sand as it was in Sturgeon Lake. People are asked to harvest small Northerns. Also there is a low population of Perch which is the primary food for Walleyes. Walleyes are at lo-normal

amounts for a lake of this type. In 2011 it was decided to stock Walleye fingerlings every fall in Sand Lake. The pan fish and bass population is good.

b.Brush...Dennis Huddleston is again manning the brush drop-off quarry. He asked for volunteers to help. His phone number is 1-651-900-9085.

c.Education...Barb Krig was absent but it was noted that we must check with the Pokegama Association as to the date of their Fresh Water Fair. Barb's phone number is 1-218-485-8862.
