LET'S KEEP WINDEMERE WONDERFUL!

Have you heard about Windemere Township's Comprehensive Plan? Well, we have one that is over ten years old. Since May 2017 about 23 of your neighbors have been volunteering on a Comprehensive Plan Steering Committee to work with a planning consultant to update the plan for the 21st century. The plan **does not** institute any new rules but is intended to be a policy guide for the township, a reference tool for development going forward, and a guide for decision makers within the township.

After several meetings, roundtable discussions and subcommittee work the plan made 27 recommendations that touch on zoning, land and water quality, natural resource protections and goals and visions for Windemere's future.

The Comprehensive Planning Steering Committee is looking forward to sharing its work and getting your feedback before the final document is presented to the Township Board for consideration at the July 12, 2018 meeting and proposed adoption at the August 8, 2018 Town Board Meeting. Open house presentations are being offered for all township residents at Mitchell Lodge at Camp Miller on Saturday, May 5, 2018 from 1-3 PM and again on Saturday, June 23 from 9:30-11:30 AM. Steering Committee members will make a brief presentation at our June 9, 2018 meeting and be available for questions and comments. **YOU ARE INVITED TO SHARE YOUR THOUGHTS AND SUPPORT THE PLAN.**

Windemere Township Shoreland Zoning Ryan Clark, Zoning Administrator

Lake Associations play a vital role in educating and helping property owners voluntarily conserve water quality and fish/wildlife habitat. As a land use zoning official, I have the difficult role of regulating development on private property along our lakes. These regulatory and voluntary approaches to natural resource conservation work together to keep our lakes in a healthy ecological state. Here in Windemere we are lucky to have lakes with good water quality and fish habitat. I applaud Windemere Lakes Association's efforts to promote wise land use that results in further water quality protection.

Shoreland Zoning Ordinances vary across the State, but they all must meet or exceed the restrictions of the higher jurisdiction. Here in Windemere Township we must meet Pine County's Shoreland Zoning, and further yet, Pine County must meet the State of Minnesota Shoreland Zoning requirements. All this means, is most of the requirements are passed down from the State. The goal of a well written zoning ordinance is to protect natural resources while allowing responsible development of private property. No-one likes to be told what they can do with their property, so it is important to understand the shared responsibility every property owners have in protecting our lakes. Not all parcels in the township were created equal by mother nature, and many lot configurations can cause frustration when trying to comply with zoning rules. The Township Zoning staff is here to help property owners plan for projects that meet their goals but also comply with ordinance requirements.

When working on a project in the shoreland zone (1000' from lake) there are several things to consider. Beyond basic shoreland best management practices like not mowing or using fertilizer near the lake, tree and native vegetation removal is restricted in ordinance. Grading and filling

within the shore impact zone (half the distance of structure setback from lake) requires a permit in most cases. Areas with slope exceeding 15% cannot be altered and wetlands must be identified and avoided when working in shoreland.

When planning a new structure or addition there are size limitations and set back requirements. Structural coverage on a lot is calculated as a percentage of lot area and vary depending on sewer status. I encourage everyone to read through our most up-to-date Zoning Ordinance. We are in the process of developing a new Comprehensive Plan. Volunteers continue a 15-year ice cleanup tradition on White Bear Lake. The event began back in 2004 as an Eagle Scout project for 11 different Boy Scout Units and since then has become an annual event. This year 134 volunteers from 11 different Scout Units and the Minnesota Geocaching Assoc. collected more than 700 pounds of trash that otherwise would have dropped into the lake when the ice melted!!! Organizers estimated that the annual cleanup has prevented more than three tons of litter from sinking into the lake over the years. So, let's remember to clean up the ice!
