Island Lake Outlet Project Completed

The Island Lake Outlet project has been completed! The old culverts were removed. In their place, there is an open channel that leads back to the county road culvert. Different sized rocks have been placed in the channel. The banks have been sloped and seeded.

Also, part of the channel further back towards the county road culvert has been cleaned out to allow water to flow freely. There was a lot of sediment back there, prohibiting water flow, which was a big issue in larger rain events.

I am very happy to say "it is done". This has been a very long process to get to construction and completion. I am very thankful for everyone that helped along the way!

Dan Benzie – Island Lake: My wife Sue, our two sons and I moved to Island Lake in 1984. WTLA High Water Committee - Sturgeon Lake

At the August 2019 Association General meeting a committee was established to seek a solution to the record high level of water on Sturgeon Lake. Bill Yechout, directors Mark Dunaski and Terry Peterson were designated as leads with Bill being designated as chair of the committee. Several other Sturgeon Lake residents also volunteered.

It was decided to gather information regarding the damage caused by the high-water levels and costs associated with repairs. A survey form was developed and mailed to 277 lakeshore owners. Nearly 100 were returned describing the types of damages experienced and costs expected or already incurred for repairs. These costs have exceeded \$1,000,000.

The survey requested information on 12 categories of potential damages. The results of the survey are being tabulated. The results will be provided to all government agency officials who have any level of jurisdiction over public waters and to elected officials for our area and others as appropriate. The goal is to find agreement on the most feasible method to lower and maintain a water level and then seek funds to implement. Eurasian Milfoil Research for Windemere Township Update By Sherry Lahti, Board Member WTLA

As most of our members know, Eurasian Watermilfoil (EWM) samples were collected from Sand Lake and Sturgeon Lake on July 11, 2019, and July 12, 2019 respectively. The EWM samples were sent to the Thum Laboratory at Montana State University where they underwent genetic testing to determine if hybrid milfoil is present in these lakes. The study was funded by a grant from Pine County and over 100 samples from various locations were collected from each lake. The purpose of the study was to investigate if there was hybrid milfoil present, and if so, adjust our treatment protocols

Lab results indicated that all samples were "pure" and no hybrid clones were detected.

Based on the results of this study, the following recommendations were suggested from the AIS researchers;

- 1- Continue tracking future research efforts at University of Minnesota and Montana State.
- 2- Explore experimental approaches to managing EWM within the lakes, potentially with partnerships with the University, Pine County and other agencies.
- 3- Communicate and/or collaborate with other lake associations and lake groups to share and obtain EWM treatment data, information etc.
- 4- Carefully document EWM treatment actions and track effectiveness.

<u>So, the good news is we DO NOT have hybrid milfoil in either lake.</u> The bad news is, we have to go back to the drawing board to try and figure out why our current treatments are less than effective in treating this Aquatic Invasive Species. Stay tuned for more info as we meet with the DNR, Pine County etc.
