## WTLA High Water Committee – Sturgeon Lake Update

Last summer Windemere Township reviewed the report which was received from Huston Engineering. The Township had asked the DNR for input last fall on the feasibility study.

The DNR did respond around the first of the year. They evaluated all the proposed routes and offered several concerns. All of the options that were suggested in the report would involve pumping the water at some point. This would be very expensive and would require yearly maintenance. The only way to fund a project like this would be through state bonding or creating a lake improvement district. The lake water has been down around 2 feet since 2019. I feel the support for funding a project of this size at this time would be hard. We will talk more about it at our first meeting.

Last fall the creek on the west side of Sturgeon was cleaned out and the culvert under Lakeland road was cleared. Hopefully this creek will be able to take some of the pressure off of Sturgeon during high water events. You can view both the engineers report and the DNR report on our web site



## Aquatic Invasive Species Research for Windemere Township Update

As mentioned in the previous fall newsletter, the goals for the AIS committee were: 1) continue to research and apply for future AIS grant opportunities, 2) support the DNR in 2024 with milfoil surveys in order to produce maps for guiding treatment activities, and 3) expand our emphasis on AIS education and prevention.

- During this past winter, we applied for and received, two traditional grants from the state/county which historically have helped to supplement the association's AIS fund when addressing milfoil on Sand and Sturgeon. In addition, we identified some exciting future grant opportunities with the DNR which could benefit an array of naturalist and sustainability type projects throughout our *entire* township. We are currently in the process of developing the lake association's ability to meet these grant requirements. Regarding these grant possibilities, we are looking forward to hearing ideas from members about what we could create together regarding improving and protecting our lakes and their associated ecosystems.
- The DNR will survey Sand and Sturgeon for areas containing milfoil when the lakes have warmed and lake vegetation is growing. Our association will provide support as we always have. **Last**

**year was a significant downward trend in acreage requiring treatment**, and our association is positioned well again this year to continue with the same methodology and milfoil management practices used in recent years. We will have aerial maps of these two lakes by July representing any areas of infestation. Per the DNR, the recommended window in the growing season for any milfoil treatment by a third-party is typically late summer. Please remember to clean, drain, and dry when transporting watercraft between bodies of water.

- Let's continue the conversation about Purple Loosestrife. It does exist in Windemere Township. It invades wetlands, impacts hydrology, and reduces biodiversity. It has been reported to the DNR. In January, some of the board met with our DNR representative and received an insightful presentation of what this invasive wetland plant is, how it functions, and how the DNR has been managing it across other parts of MN since the 1980s. We are planning to share the same presentation at one of our general membership meetings this summer. Fortunately, the DNR has developed some successful (and interesting) methods for managing large stands of this plant. In addition, our lake association can participate at no cost. The initial action item will be to identify and report as many geographical locations as possible which contain stands of this plant when it blooms July to September. The follow up action during this same time period will be verification and assessment by the DNR before they assign additional resources to this risk.
